- 1. **The Full Wholeness Pastoral Care Course** is merely a biblical "framework" aiding those having pastoral conversations to navigate the complexities of people's stories whilst helping point people back to a right relationship with God.
- 2. This training **does NOT** qualify me to set up my own private practice as a Professional or Pastoral Counselor under any circumstances.
- 3. **EDIFY does NOT** advocate formally charging anyone under the umbrella of pastoral care, as this course does not provide one with a formalized recognized qualification.
- 4. **EDIFY does** encourage all who wish to engage in **formal** pastoral care conversations, to be a part of their local church's formal pastoral care team.
- 5. **EDIFY does** encourage all who serve on their local church's formal pastoral care team to attend a basic up-to-date ethics course annually.
- 6. **EDIFY does** encourage all those who serve on their local church's formal pastoral care team to attend regular group supervision and to attend on-going development courses.
- 7. **EDIFY does** encourage all who serve on their local church's formal pastoral care team to work in **pairs**, therefore enabling accountability, mentorship, safety around boundaries, and the elimination of potential co-dependency.
- 8. **EDIFY does NOT** take responsibility for how any of "**The Wholeness Training**" may be applied outside of **EDIFY**'s consent, knowledge, or supervision after completion thereof.

PLUS: I am aware of the expectations needed from this student in order for them to obtain an EDIFY endorsed pastoral care certificate. I take full responsibility for this student on my pastoral care team, should they meet the criteria's listed below.

Level 1 - The Wholeness Course:

Students need to obtain **70%** or more for their **on-line theology quiz**, thereby showing their understanding of the theology of Wholeness, (multiple attempts are allowed.)

Level 2 – The Wholeness Model:

Students need to obtain **60%** or more for their **2000 essay**, by showing their ability to apply a presenting problem in their own personal life to the Wholeness Model. (Two attempts allowed)

- Unpacking clearly a presenting problem = 10%
- Presenting relevant information in the 10 basic life areas to the presenting problem = 20%
- Present clearly how they have been maintaining their presenting problem through their unhelpful processing patterns = 30%
- Present clearly how this person is to bring this back to a right relationship with Christ through the "thirsts" level of the model = 20%
- Presenting how they would re-processing themselves according to truth and live out a new story = 20%

Level 3 – Wholeness Counselling Skills:

Students need to submit a 15 min video or audio of them counselling a client of their choice – they need to obtain **60%** or more for their assessment. (Two attempts allowed.)

- a. It is recommended that students scoring between 60%-79% be mentored by an experienced lay-counsellor.
- b. Students scoring between 80%-100% are strong enough to mentor others.

Students who pass will received an *Edify Endorsed Pastoral Care Certificate*Students who fail level 3 but passed Level 1 & 2 will receive an *Edify Endorsed Advance Discipleship Certificate* - they are encouraged to sharpen their skills in spaces like a Wholeness Small Group Leader or through informal Coffee Cup Convo's.
